10 repealed and reenacted to read as follows:

11 (d)(1) An additional \$2,037.11 for each pupil in the ADMR who is receiving special
12 education services with a category A disability and \$3,367.08 for each pupil in the ADMR who is
13 receiving special education services with a category B disability.

14 (2) For this subparagraph, "category A disability" applies to pupils receiving special
15 education services with a primary disability that includes developmental delay, specific learning
16 disabilities, and speech or language impairments; and "category B disability" applies to pupils
17 receiving special education services with a primary disability that includes autism, deaf-blindness,
18 emotional disturbance, hearing impairments, multiple disabilities, intellectual disability, other
19 health impairments, orthopedic impairments, traumatic brain injury, acquired brain injury, and
20 visual impairments.

6 I. In addition to aid for the cost of the opportunity for an adequate education provided under
7 RSA 198:40-a, each year the commissioner shall calculate an extraordinary need grant for schools
8 and provide that amount of aid to a municipality's school districts as follows:

9 (a) A municipality with an equalized valuation per pupil eligible to receive a free or
10 reduced-priced meal of \$1,000,000 or less shall receive \$650 per pupil eligible to receive a free or
11 reduced-price meal in the municipality's ADMR.

12 (b) A municipality with an equalized valuation per pupil eligible to receive a free or
13 reduced-price meal between \$1,000,001 and \$5,999,999 shall receive a grant equal to \$0.00013 for
14 each dollar of difference between its equalized valuation per pupil eligible to receive a free or
15 reduced-price meal and \$6,000,000, per pupil eligible to receive a free or reduced-price meal in the
16 municipality's ADMR.

17 (c) A municipality with an equalized valuation per pupil eligible to receive a free or
18 reduced-price meal of \$6,000,000 or more shall not receive an extraordinary need grant.

19 II. In order to receive an extraordinary need grant, the school district shall provide a plan to
20 the department of education outlining how the district intends to improve the educational
21 achievement of students. School districts eligible to receive the grant shall provide the department
22 an accountability plan designed to generate data that measures student academic achievement and
23 growth of knowledge and skills in reading and language arts and/or mathematics in grades 3-8 and
24 at one grade level in high school. A school district receiving a grant award shall submit to the
25 department for approval a grant accountability plan identifying program design elements as
26 required by the department and at what grade levels the funds will be used. The school district, in
27 consultation with the department, shall develop and administer its own grant accountability
28 assessment that identifies a pupil's range of learning and yields objective data to use in improving
29 instruction and learning, or use the statewide assessment. The school district shall submit to the

7 basis for the local tax assessment in the determination year, divided by the school district's
8 kindergarten through grade 12 ADMR in the determination year eligible to receive a free or reduced-
9 price meal.
